2 Background

2.1 About Uttarakhand

Uttarakhand was formed on 9th November 2000 as the 27th State of India, when it was carved out of northern Uttar Pradesh. Located at the foothills of the Himalayan mountain ranges, it is largely a hilly State, having international boundaries with China (Tibet) in the north and Nepal in the east. On its north-west lies Himachal Pradesh, while on the south is Uttar Pradesh. The state is divided into two divisions, Kumaon and Garhwal, with 13 districts. The capital of Uttarakhand is Dehradun, which is the largest city in the region and is also well connected to rest of the country via rail, road and air ways.

The State is rich in natural resources such as forests, glaciers, rivers etc. and is also gifted with almost all major climatic zones, good rainfall, good rail and road communication, technical educational facilities, research laboratories, management institutes, etc.

With a view to catalyse growth in industrial sector which aims to utilize resources available in Uttarakhand and which can generate employment for local inhabitants, the State adopted “Ease of Doing Business” initiative of DIPP, Government of India.

Uttarakhand was ranked at number 23 in 2015, number 9 in 2016 and number 11 in 2017, in the Ease of Doing Business (EODB) rankings by DIPP.

2.2 Objective

The Government of India has undertaken series of reforms to make India into an easier place to do business. There is still a growing need to do a lot more to achieve the vision of becoming top State in ease of doing business. There are major requirements of business reform initiatives to be undertaken by the concerned Ministries and departments for promoting ease of doing business in the State.

In this regard, Directorate of Industries (which is the nodal department) intends to on-board an agency, for a period of two years, to assist and support State Government in improving the business climate by ensuring effective and on ground implementation of reforms including Single Window Clearance System and Investment Promotion.

Investor Promotion Facilitation Centre has been set up in the Directorate which needs to be further strengthened.

2.3 Scope of Work

The Scope of Work for the proposed engagement will primarily consist of the following modules:

- a) Dedicated Team for Business Reform Action Plan (BRAP) compliances.
- b) Dedicated Team for Existing Single Window Portal maintenance and development according to BRAP & Investors requirement.

c) Dedicated Team for Investment Promotion.

The detailed scope, team composition and project duration would be defined in the RFP stage.

3 Criteria for Shortlisting

The bidder must possess the requisite experience, strength and capability in providing the services necessary to meet the requirements as described in the tender documents. The bidder must also possess the technical know-how and the financial resources that would be required to successfully provide the services for assisting Directorate of Industries in EODB, Single window and Investment Promotion in the State of Uttarakhand. The invitation to this REOI is open to all bidders who qualify the eligibility criteria as given below:

4 Evaluation Process

- i. The DIRECTORATE will constitute a Proposal Evaluation Committee to evaluate the responses of the bidders.
- ii. The Proposal Evaluation Committee constituted by the DIRECTORATE shall evaluate the responses to the REOI and all supporting documents / documentary evidence. Inability to submit requisite supporting documents / documentary evidence, may lead to rejection.
- iii. The decision of the Proposal Evaluation Committee in the evaluation of responses to the REOI shall be final. No correspondence will be entertained outside the process of evaluation with the Committee.

5 Instruction to the Bidders

5.1 EoI Preparation Costs

The bidder shall be responsible for all costs incurred in connection with participation in the REOI process, including, but not limited to, costs incurred in conduct of informative and other diligence activities, participation in meetings/discussions/presentations, preparation of EoI, in providing any additional information required by the DIRECTORATE to facilitate the evaluation process and other costs related to the bid process. The DIRECTORATE will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the bidding process.

5.2 Language


